Enclosed is the accounting due on March 1, 1957. You will note at once that try as we do, we never seem to reduce the total effectively. Once again I must point out that this results from two factors: the large unpaid balance and the unusual expenses in connection with our activities for which there is no budget. Although we have approached the point, where certain of these unpaid expenses in connection with the Middle Eastern crisis are notably reduced, we are now confronted with the very large expenses for the Madison Square Garden rally.

The \$2,527.51 will cover the following items as part of the Special P.R. items:


