In 1965 and 1966, we conducted investigation of Shapiro under the Registration Act character. In February, 1966, the Atomic Energy Commission (AEC) contacted the Bureau concerning the alleged loss of 61 kilograms of U-235 from NUMEC. AEC was interested in having the Bureau conduct an investigation. We declined to conduct the investigation since the information presented to us indicated the loss of the U-235 resulted from faulty administrative and recording practices at NUMEC.

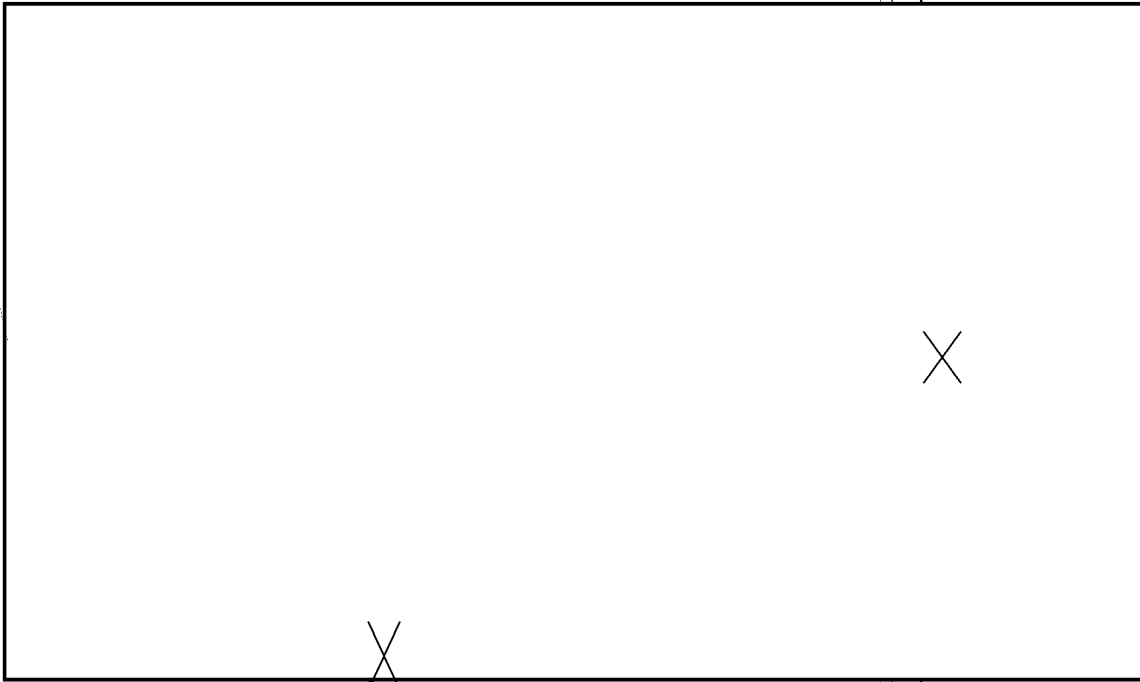

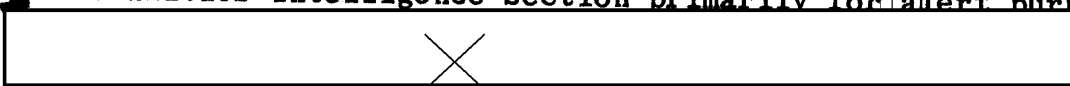

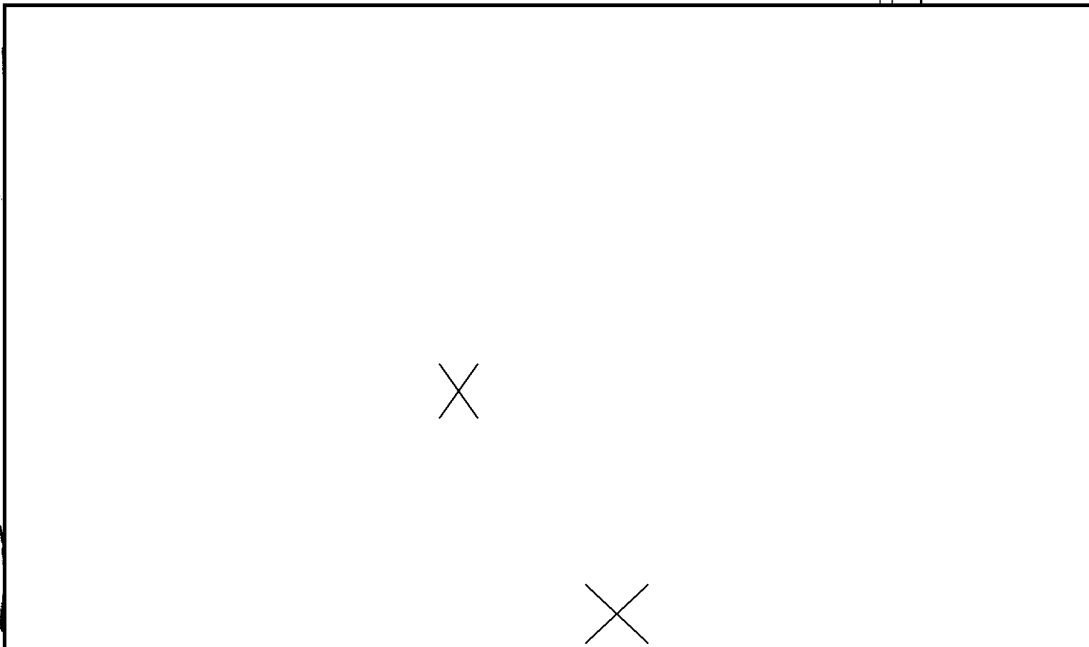

In accordance with instructions in Buairtel 5/20/68, WFO has requested appropriate checks of the files of the Passport Office and Office of Security, USDS, [redacted]

[redacted] Those requests are still outstanding. Pertinent results will be reported upon receipt. Copies of an available passport photo of the subject are being made and will be forwarded to interested offices upon receipt of the same.

On 6/7/68, SA [redacted] made a preliminary, cursory review of files maintained by AEC, Germantown, Maryland, in the case involving NUMEC. These files are rather voluminous and contain the results of numerous security checks and efforts to have NUMEC tighten its security in accordance with AEC requirements as well as extensive reporting resulting from the investigation into the cumulative loss of enriched U 235 at NUMEC. SA [redacted] made contact with certain interested AEC personnel and was assured of complete access to AEC files.

With reference to the pending review of AEC files, the various individuals contacted during SA [redacted] 6/7/68 visit to AEC were unanimous in agreement that there probably

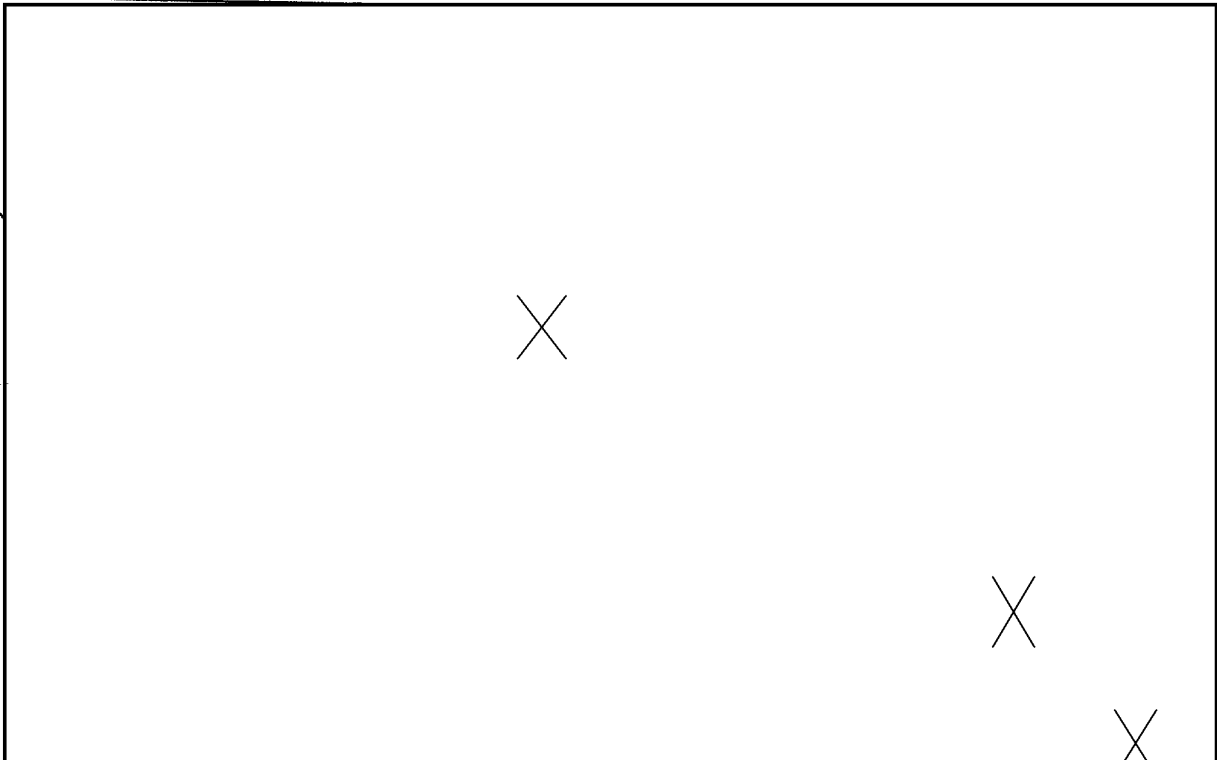

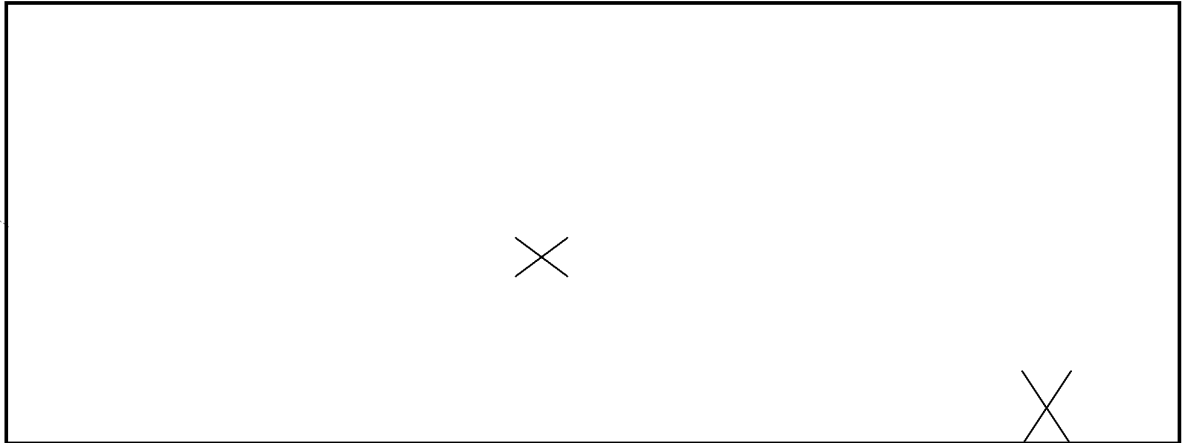

Pittsburgh is contemplating contact with other banks in the Pittsburgh area for the purpose of monitoring subject's bank accounts, but only at this point in the investigation through well-established sources.

Discreet and carefully planned fisurs of subject have disclosed that subject leaves his residence for Apollo, Pa., between 7:40 a.m. and 8:11 a.m. He generally drives a 1967 four-door, dark blue Buick Electra, bearing Pennsylvania license 22170H, but has on two occasions driven an approximate 1967 four-door bronze Ford sedan, bearing Pennsylvania license 22171H. He travels to his place of employment in Apollo, Pa., to date, nonstop, using the same route. He is known to generally travel at very high rate of speed.

Investigation was instituted at the request of the Attorney General to establish the nature and extent of Zalman Mordecai Shapiro's relationship with the Government of Israel. This could be connected with, or in addition to, or as a result of, his association with Israeli officials and sympathizers in the United States.

(u) ~~(S)~~ [On June 5, 1968, a source, contact with whom has been insufficient to judge the reliability of his information] but who is a businessman in a position to furnish information concerning the activities of the subject and who is described by his associates as being a reliable and respectable individual, advised that Zalman Mordecai Shapiro is the President of Nuclear Materials Corporation (NUMEC), of Apollo, Pa. Source advised that NUMEC, a producer of nuclear materials, and Raychord Corporation, a steel fabricating company, occupy the same building, which is located at Warren and North Seventh Avenues, Apollo, Pa. Source advised that NUMEC has at least five other locations in the Apollo area. The President of Raychord Corporation is David L. Lowenthal, a long-time close personal friend of subject. Source advised that Lowenthal is also an officer of Apollo Industries of Pittsburgh, Pa., a company which was instrumental in establishing NUMEC through investing a substantial amount of money in NUMEC stock. Source advised Lowenthal and subject are frequently observed together and generally have lunch together at a restaurant in Apollo where a number of employees from both Raychord and NUMEC eat. Source further added that Lowenthal and subject reside near each other in Pittsburgh, Pa.

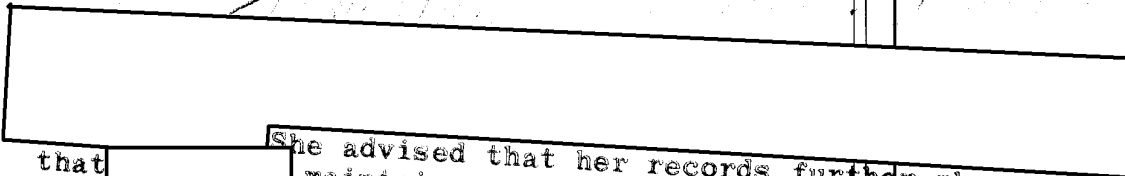

Source advised that Apollo Industries, Inc., Pittsburgh, holds 45% minority interest in Raychord, and that a large portion of the balance of stock, although not necessarily a controlling interest, is held by Philip Sweig and Sons, Gary, Indiana. A minority interest is also held by Raymond Torres, at least on an option-to-buy basis, up to one-third of the capital stock. Source advised that the fiscal May 31, 1967, annual report of Apollo Industries indicated that they have made loans and advances to Raychord for \$2,640,304. Also, at that time, Apollo Industries held \$25,000 of outstanding common stock and \$350,000 of preferred stock in this company.
