Dear Zionist Activist/Student --

The ADL has brought Raanan Gissin, an officer in the Israeli Defense Forces, in from Israel to speak on the Israeli military statue and strategy in Lebanon--something that we are all concerned about in light of recent events.

At this meeting, we will also discuss the materials we are sendir along to you at this time.

I believe the steering committee will take little time away from your other (undoubtedly Zionist) activities and should prove to be quite helpful. I hope to see you on the 15th.
