What does it take to mount a sustained direct lobbying campaign?


- Longevity/trajectory
- Teams of effective, full-time lobbyists.
- A highly developed lobbying agenda.
- Ability to translate that agenda into legislation.
- Financially robust host organizations:
 - AIPAC \$105 million
 - ADL \$75 million
 - AJC \$75 million

Christian Zionists don't matter much in the direct lobbying world.


- CUFI Action, the largest, appears to be more of a "cutout" than an independent direct lobbying organization.
 - David Brog, cousin of former Prime Minister of Israel Ehud Barak on Sheldon Adelson payroll.
 - Received startup funding from Goldhirsh Foundation
 - Unknown donations/donors
- Mostly follow lead of the mainstream Jewish Israel lobby. E.G. 1995 Jerusalem Embassy Act
- Haven't been around very long
- No visible lobbying on top Christian Zionist objectives.




Christian vs Jewish Establishment Israel Lobbying Expenditures (\$3.6 million 3Q19-2Q2020)



Categories of AIPAC Direct Lobbying

- Propaganda Directed at Americans, Congress, foreign countries, the rest of the world.
- Entanglement Infiltrating Israeli government, corporations and NGOs into major, cuttingedge US government and private sector initiatives.
- Subsidies US tax dollars for Israeli R&D, free U.S. weapons, etc.
- Coercion Direct U.S. influence to force Israeli initiatives onto other countries, often against public opinion of target countries.
- Anti-Human Rights Advancement of Palestinian human rights (opposed by AIPAC).
- Israel Primacy AIPAC lobbying on non-Israel centric bills as a way of building influence, threating agency budgets and constantly "showing the flag."
- Economic Warfare Directing US agencies (mostly OTFI) against Israel's rivals.
- Israel Veto Giving Israel authority over US sovereign decisions.


AIPAC Direct Lobbying initiatives by Major Category


- 1960s theft of USG nuclear material.


AIPAC Israel Direct Lobbying by Sub-Category – Entanglement – 22%



Cumulative *Publicly Known* U.S. Foreign Assistance to Israel 1949-2019 (\$260.9 billion)








Arab Public Opinion: Anti "normalization"

- 88% of citizens refuse to recognize the state of Israel, citing political reasons as opposed to religious or cultural ones.
 - The majority of Saudi citizens reject recognition of Israel.
- 91% of Arabs believe that financial and administrative corruption is present in their country to varying degrees.
- 76% of Arabs support a democratic system.
- 74% of Arabs stated that a pluralist democratic system would be appropriate for their countries.








- Senators Symington and Glenn passed 1970s laws banning U.S. economic, and military assistance, and export credits to countries that deliver or receive, acquire or transfer nuclear enrichment technology when they do not comply with IAEA regulations and inspections.
- Israel and the lobby have successfully pressured presidents Clinton through Trump to sign secret letters pledging not to enforce the law.
- The Obama administration implemented rules making it illegal for any government official or contractor to discuss or release information about Israel's nuclear weapons.

HR8494 "Guaranteeing Israel's QME Act of 2020"

"(4) CONSULTATION REQUIRED.—The President shall seek to consult with appropriate officials 3 of the Government of Israel for information regarding Israel's qualitative military edge before making 5 a determination under paragraph (1). "




Known U.S. Foreign Assistance to Israel Since Passage of Symington & Glenn 1976-2019 (\$228.8 billion)

In summary

- US aid to Israel has long been illegal under the Arms Export Control Act.
- It takes top to bottom corruption, propaganda and entanglement to unlawfully deliver that aid.
- The Israel lobby increasingly wants a law for "veto power" over U.S. sovereign decisions while entangling Israel into key sectors.

But what if the Israel lobby became part of the government?

- Not just created by and staffed with handpicked political appointees like OTFI.
- Not just unduly influenced like the White House and Congress.
- But actual US government agencies created to do Israel's bidding?

The Virginia Israel Advisory Board

- Launched by Eric Cantor in 1996
- Scours Virginia state funding pools for grants, loans and other support exclusively to Israel companies.
 - Virginia Coalfield Economic Development Au
 - Tobacco Region Opportunity Fund
 - Virginia Economic Development Partnership
- Scours Federal funding sources for
 - Research grants
 - Tax Credits
- Subsidy-powered takeover of Virginia and US competitor market share



What is VIAB? What VIAB really does:

- Israeli export promotion council
 - Connects Israeli companies to VA state funding sources
 - Engaging consultants to perform market entry strategy
 - Launch new operations to compete against state and US competitors.
 - Tap other government entities for support.
 - Assumption: Israeli companies inherently have a lot to offer.
- Consolidates the most active Israel lobbying groups the local Jewish federations - into VIAB board slots (4 by statute)
 - Large state political campaign contributors
 - VIAB has involved other large contributors to the Governor on Israel missions to pressure signing MOU's and commercial deals
- Connects Israel lobbying initiatives inside and outside state government
 - Federations backing it working on changes to state K-12 textbooks
 - Anti-1st Amendment state resolutions and laws
 - Cross-promotion of fellow VIAB board members like Eileen Filler-Corn.
- Drafts other state agencies to become appendages of Israeli business interests
 - Virginia Tech Sabra Dipping Company MOU.



Dear Mr. Lessin,

In 2014, a grant from the Tobacco Region Revitalization Commission (TRRC) Tobacco Region Opportunity Fund (TROF) was provided to your company, Appalachian Biofuels LLC (the "Company") to manufacture biodiesel in Russell County, Virginia (project # 2941). The TROF grant in the amount of \$565,000 was provided prior to performance based upon the promise of 40 new jobs. The promised capital investment was \$3,500,000. The period of performance was for 3 years from June 30, 2014 – June 30, 2017. The grant was disbursed in two installments, \$210,000 in September 2014 and \$355,000 in December 2014. The first installment of \$210,000 was invested in project-related costs and the second installment of \$355,000 was reserved in an escrow account.

In 2016, the Commission was notified that the project was not moving forward due to a drastic decline in world oil prices. In early 2017 the Commission notified the Company that the full grant amount of \$565,000 must be repaid for failing to meet the performance obligations. In early January 2018, the Commission's Executive Committee considered an appeal from the Company to reduce the clawback amount. After consideration, the Executive Committee declined to reduce the clawback and requested that the Company work with TRRC staff to develop a repayment plan. On January 22, 2018 the Company repaid the \$355,000 leaving \$210,000 to be repaid to the Commission.

In a February 2018 meeting with between TRRC staff and yourself, it was agreed that in your capacity as a member of the Virginia Israel Advisory Board, over a two-year period, you would work to meet the performance metrics promised as part of project 2941 (40 new jobs, capital investment of \$3.5M) to the Commission's footprint.

In July 2019, at the request of TRRC staff you provided a detailed confidential listing of the projects you have (and continue to be) involved with that are within the Commission footprint. After reviewing the locations, capital investment and jobs provided with these projects, TRRC staff can confirm that you have fully met the employment and capital investment obligations as agreed and the project can be closed. Thank you for your partnership with the Commission and please be in touch should you have any follow up questions.



US-Virginia Subsidies to Energix

- If Energix reached/reached its original estimated CAPEX for Virginia it would have received \$140 million
 - Morgan Stanley is the US "Tax Partner" turning Energix tax credits into investment cash.
 - This creates a "tax gap" for others to fill.
- Forgivable PPP loans (based on a claimed US headcount of 152 employees)
 - \$2-\$5 million (one-third of all the PPP forgivable loans in the \$350,000-and-above category given to Virginia solar companies.)
- In 2020, the Virginia Jobs Investment Program <u>announced it will</u> <u>subsidize</u> Energix's human resources costs to open its headquarters within an Alony-Hetz owned property in Arlington County.



Case Study: Oran Safety Glass

- Oran safety glass formed in a kibbutz in central Israel in 1979 to manufacture "transparent armor."
- VIAB brought Oran to Greensville Country Virginia near Emporia to manufacture in county-owned industrial park.
- Code-named "ballistic."





- "All board members are asked to refer to the project by this code name. Leaked information could jeopardize funding opportunities from the state." – VIAB Board Meeting
- \$10 m VECEDA loan award.

Why a Virginia location?





2006 US Hummus Market




2015 US Hummus Market



U.S. Israel Free Trade Agreement Damage Assessment


Why has the Israel Free Trade Area Agreement (ILFTA) been so bad for America? Will Israel and its lobby advance even worse U.S.-Israel initiatives?

On this day 35 years ago following bitter complaints by U.S. exporters, the FBI launched a counter espionage investigation targeting the American Israel Public Affairs Committee (AIPAC) and the Israeli embassy. U.S. exporters at the time were near unanimously opposed to opening the vast U.S. market to Israeli exporters in exchange for limited, variable and tightly controlled U.S. access to Israel's tiny market.

AIPAC and Israel worked every angle to pass the 1985 U.S. Israel Free Trade Area Agreement (ILFTA). ILFTA was the first of a string of so-called "Free Trade Agreements." The joint effort by Israel and its lobby included stealing and using data provided in confidence by U.S. exporters to the International Trade Commission, which ITC had compiled into a classified report called "Probable Economic Effect of Providing Duty Free Treatment for U.S. Imports from Israel, Investigation No. 332-180."

By purloining and using the report against U.S. industry, and leveraging a vast coordinated political campaign contribution system, the Israel lobby won passage of ILFTA in 1985. ILFTA has produced a \$182.25 billion bilateral trade deficit in goods. This report examines why ILFTA is the worst performing bilateral FTA in terms of cumulative trade deficit, surpassed only by the multilateral NAFTA deal.

- VIAB is a profit privatizer and loss socializing engine in Virginia.
- Key projects, like Jonah, are supported by AIPAC.
- VIAB obtains undue access for its portfolio of companies by getting funds and clearing regulatory hurdles from within government. Normal companies don't have that access.
- The small handful of insiders who profit, can reinvest the funds in campaign contributions to increase VIAB and AIPAC power and influence.
- Nearly impossible to discover if jobs and CAPEX performance targets were met.
- News media self-censorship.
