stated that his source went on to relate bforce that HOFFA discussed his future plans which included getting back into the Teamster organization and obtaining control of this organization at a future time. The source stated that HOFFA is attempting to subtly sabotage the efforts of the current Teamster president, FRANK FITZSIMMONS, until he can no longer control the organization.

HOFFA stated that some time in the near future, believed to be around the end of April, 1973, there is going to be an Israel bond rally in Washington, D. C., in honor of FRANK FITZSIMMONS. It is expected at that time that all of the Jewish leaders and friends of the union will turn out and purchase large amounts of bonds for Israel.

At the Las Vegas meeting, GREENSPUN and SARNO, along with HOFFA, stated that they thought one of the ways which would take some of the importance out of this forthcoming meeting was to have an Israel bond rally in Las Vegas in honor of HOFFA. This way, many of the purchasers who would have normally purchased Israel bonds at the FITZSIMMONS rally would have possibly contributed and purchased bonds at the HOFFA rally cutting down on the importance of the rally in honor of FITZSIMMONS.
